- (c) Copy of the certificates mentioned below with their original for verification:-
 - i) Matriculation/Hr. Sec. Certificate for verification of date of birth.
 - ii) B.A./M.A./M.Ed./M. Phil. Degree and marks-sheet.
 - iii) Experience certificate from the employer (a) for Teachers of Delhi University/College holding permanent, temporary or ad-hoc position with a minimum of 2 years experience; (b) for permanent teachers in any other recognized University/College/Research Institute with a minimum of 3 years teaching/research experience (if any).
 - iv) Letter from the employer/any other recognized University/College/Research Institute sanctioning study leave for a period of 2 years
or
In the case of candidates who are employed, a copy of their resignation letter and acceptance of it from the University/College/Research Institute.
 - v) Letter of award of Fellowship (if any).

It may further be noted that:-

- (a) The precise topic of research will have to be specified in consultation with the Supervisor within a period of one year of admission.
- (b) Ph.D. students have to pay fees annually in advance and submit a photocopy of the fee receipt to the office of the Department, failing which their names will be struck off the rolls.
- (c) The candidate will have to complete the in-residence condition of 2 years (w.e.f. date of joining the course) as per the Ph.D. Ordinance VI-B.


He/She is required to complete the following requirements of admission within three months from the date of despatch of this letter, failing which, his /her admission shall be treated as cancelled without any further notice:-


