


Sir,

1. Your item rate tender for the work mentioned above has been accepted by the competent authority on behalf of SPM College, amounting to Rs. 7,90,150/- (Rupees Seven Lakhs Ninety Thousand One Hundred Fifty Only) which is approx. 35.22% below the estimated cost of Rs. 12,19,787/- (Rupees Twelve Lakhs Nineteen Thousand Seven Hundred Eighty Seven Only) subject to depositing the amount equal to 5% of tendered rates of the work as performance guarantee.
2. You are requested to submit the performance guarantee @5% of the tendered rates amounting to Rs. 39,510/- (round off) (Rupees Thirty Nine Thousand Five Hundred Ten Only) in the form of irrevocable bank guarantee bond of any scheduled bank or state bank in accordance with the form prescribed or in cash or in form of Govt. Security, fixed deposit etc. within seven days of the issue of letter of intent but before the award of work. This performance guarantee shall be valid for six months.
3. You are required to bring a non-judicial stamp paper of Rs. 100/- for the signing the formal agreement within seven days from the date of this letter.
4. On receipt of the prescribed performance guarantee and Non-judicial stamp paper, the formal letter of award of work shall be issued.
5. The other terms and conditions as mentioned in the tender document shall be valid and binding.
6. Please note that the time allowed for carrying out the work as entered in the tender shall be Forty days (40 days) which shall be reckoned from the date of issue of LOI / Work order.



7. Compensation for delay of work @ 1.5% per month of delay will be computed on per day basis and levied on the contractor on delay of work.
8. It is also to inform that all the documents / papers relating to above tender which have been submitted on CPPP Portal should be submitted again duly self-attested in the college prior to award of work.
