## 2.2 List of Documents required at the time of Admission

The Candidates shall be required to upload copies of relevant certificates/documents at the time of applying (as applicable) and produce the same certificates/documents in original at the time of physical verification at the College.

1. Class X Certificate in the name of the candidate, indicating date of birth and Parents' names.
2. Class XII Marksheets in the name of the candidate. The name of the candidate must match with the CUET(UG)-2022 form.
3. SC/ST/OBC-NCL/EWS/Minority/CW/KM/PwBD Certificate (in the name of the Candidate) issued by the competent issuing authority. The name of candidate claiming reservation under



SC/ST/OBC- NCL/EWS/Minority/CW/KM/PwBD must match the name that appear on his/her corresponding School Board qualifying certificate and in CUET(UG) - 2022. Similarly, his/her parents' names must match in both sets of certificates.

4. OBC - Non-Creamy Layer Certificate (in the name of the Candidate) issued by the competent issuing authority, and wherein the caste is in the OBC Central List issued by <http://ncbc.nic.in>. The name of the candidate claiming reservation under OBC -Non-Creamy Layer must match with the name as it appears on his/her corresponding School Board qualifying certificate and in CUET(UG) - 2022; similarly, the parents' names must match in both sets of certificates. Income certificate must be issued after March 31, 2022. The prescribed format of the OBC-NCL certificate is given on the UoD admission website and Annexure IV.
5. EWS Certificate (in the name of the candidate) from the competent issuing authority certifying the candidate can claim reservation under this category. The name of the candidate claiming reservation under this category must match with the name that appears on his/her corresponding School Board qualifying certificate; similarly, his/her parents' names must match in both sets of certificates. Income certificate must be issued after March 31, 2022. Refer to Annexure IV for the prescribed format of the certificate.
6. Candidates claiming admission through ECA/Sports supernumerary quota must upload self-attested copies of the requisite certificates and produce the relevant required certificates when sought.
7. For applying to B.Sc Physical Education, Health Education and Sports, candidates must upload the following (Details in Chapter 20):
  - a) Medical Fitness certificate as per the prescribed format given in Annexure IV.
  - b) Upto three Sports Proficiency Certificates.
8. Candidates who have not studied Music as a subject in Class XII and wish to apply for B.A.(Hons) Music must upload a certificate as mentioned in Chapter 20 of CSAS.

PwBD disability certificate should be in the name of the candidate issued by a recognized Government Hospital, bearing a photograph of the candidate (Refer to Annexure IV for the prescribed format of the certificate). Disability Certificates issued after 01.06.2021 must be as per the Gazette Notification no. 1736 (E) dated 05.05.2021 issued by the Department of Empowerment of Persons with Disabilities and applied through UDID portal. However, Disability Certificates issued before



01.06.2021, will be considered as per other existing applicable rules and notifications of the Department of Empowerment of Persons with Disabilities and the University of Delhi.

1. Candidates applying for the CW category must upload the Educational Concession Certificate (ECC), (in the name of the candidate) in the prescribed format wherein the Priority is clearly mentioned. Refer to Annexure IV for the prescribed format of the certificate.
2. Candidate applying for the Kashmiri Migrant category must upload the relevant certification in the correct format issued by Divisional Commissioner/Relief Commissioner.
3. Candidate applying for Sikh Minority category must upload and produce a certificate from the Delhi Sikh Gurudwara Management Committee (DSGMC) certifying his/her minority status.
4. Candidate applying for Christian Minority category need to upload and produce his/her Baptism certificate and/or Church membership certificate as per the requirements of the respective Christian Minority College.
5. Candidate who wishes to seek admission under UoD Ward supernumerary quota must upload a valid employment certificate of his/her parent/s issued by the due officials. Only the employment certificate uploaded in CSAS Application form will be considered. I-cards, Aadhar Card and/or any other document will not be accepted.

Candidates shall be responsible for the quality and authenticity of the certificate they upload. Candidates must take utmost care to ensure the uploaded documents/certificates are authentic and accurate. Candidates will be responsible to produce documents/certificates as sought. All certificates/documents will be returned to the candidate by the College/Department upon completion of any physical verification that may be required at a later stage.

If the original certificates are not in English/Hindi, the English/Hindi version/translation of such certificates, duly certified by the Principal/Director or other competent authority of the last Institute attended, will be required during the verification of documents.

## **2.3 Requirements for Admission**

### **2.3.1 General Information**

Admission to all UG Programs will be done through CSAS-2022 based on the eligibility requirements, criteria, and procedures specified by the University on its website, Under-Graduate Bulletin of Information - 2022 (UG-BOI) and Common Seat Allocation System-2022 (CSAS). Candidates must check the eligibility criteria carefully. There are no additional eligibility criteria besides the ones stipulated by the University.

### **2.3.2 Registration to Undergraduate Programs**

For admission to Undergraduate programs of the University of Delhi, all candidates (Including those applying for supernumerary seats) must register for CUET-2022 at <https://cuet.samarth.ac.in>

Candidates desirous of taking admission to School of Open Learning (SOL) must register at [www.sol.du.ac.in](http://www.sol.du.ac.in).

Candidates desirous of taking admission to Non-Collegiate Women Education Board (NCWEB) must register at University of Delhi admission website at <http://admission.uod.ac.in> (registration process to begin from May 01, 2022)

## **2.4 Mid- Entry**

Candidates who failed to apply for CSAS-2022 within the stipulated time and are desirous of participating in CSAS-2022 can participate through the Mid-Entry window (whenever University announces it), by paying a Mid-Entry fee of Rs. 1000.00 (non-refundable).

A candidate who makes a Mid-Entry may be considered for allocation only after all the candidates who had applied earlier and have the merit score/s higher than the lowest declared score have been given allocated.

A candidate who applies to CSAS-2022 mid-way will not hold any right to claim the seats allocated to candidates who had applied to CSAS-2022 during the initial Application Phase. Allocation of seats to such candidates may be considered for subsequent rounds (if any), subject to fulfillment of eligibility criteria, availability of seats, and other CSAS-2022 rules.

It will be mandatory for the Mid-Entrant to take admission on the seat allocated to him/her, if offered. Failure to accept the allocated seat will forfeit the candidate's admission to UoD. There will be no option of 'Upgrade'. The seat allocated in a particular allocation round will be final and will not be upgraded in any subsequent allocation round.



Mid-Entry will only be considered after successful remittance of the Mid-Entry fee. Merely applying through Mid-Entry does not guarantee a seat through CSAS-2022.

Mid-Entry will not be allowed for Performance-Based Programs (B.A.(Hons) Music, B.Sc Physical Education, Health Education, and Sports), and ECA, Sports Supernumerary Quota.

## **2.5 Spot Admission**

After the completion of regular CSAS-2022 rounds, if seats remain vacant, UoD may announce Spot round/s of admission.

Candidates who applied for CSAS-2022 but were not admitted to any College on the date of declaration of the Spot Admission round can participate in Spot Admissions.

On the announcement of Spot Admission, the admission of all already candidates will be locked and they will not be considered for upgrades. Similarly, the admitted candidates will not be allowed to withdraw their admissions.

To be considered in a Spot Admission round, the candidate will have to opt for 'Spot Admission' through his/her dashboard.

For every Spot Admission round the University will display the vacant seats of each Program. A desirous candidate will be able to select ONLY ONE Program.

In Spot Admissions, allocations will be done on the basis of the following criteria:

1. Availability of seats.
2. Program-Specific merit.
3. Order of Preference of College.
4. Category.
5. Any other allocation rules, policies, or criteria as mentioned in this document (CSAS-2022), UG BOI – 2022, or published on the admission website of UoD

It will be mandatory for the candidate to take admission to the seat allocated in a Spot round. Failure to accept the allocated seat in the Spot Admission round will forfeit the candidate's eligibility for admission to UoD and s/he will be out of CSAS.

There will be no option of 'Upgrade' and 'Withdraw' during the Spot Admission rounds. The seat allocated in a particular Spot Admission round will be final and will not be upgraded in any subsequent round of Spot Admission rounds.



## 2.6 Tie- Breaking Rules

In the event of a tie, where two or more candidates have the same CUET(UG) - 2022 merit score for a Program + College Combination, the following rules will be applied in the stated order to break the tie:

1. The candidate with a higher percentage of aggregate marks in the Best 3 subjects of Class XII will be given preference.
2. The candidate with a higher percentage of aggregate marks in the Best 4 subjects of Class XII will be given preference.
3. The candidates with a higher percentage of aggregate marks in the Best 5 subjects of Class XII will be given preference.
4. Age of the candidate; preference will be given to the candidate having an earlier date of birth (as mentioned in the Class X certificate).

Note:

1. If the mark sheet contains both Class XI and Class XII marks, only Class XII marks will be considered.
2. Any discrepancy in the entry of marks pertaining to the Theory, Practical or Total, will be the sole responsibility of the candidate.
3. If the Class XII mark sheet contains CGPA/Grades, the candidate will have to convert the Grades into equivalent marks/percentages as per the issuing examination board (refer to Annexure II for Grade conversion).

## 2.7 Programme /Course-wise Requirements

### Eligibility Requirements for Undergraduate Admissions

#### Common Minimum Eligibility\*

The candidate must have passed the Class XII or its equivalent examination from a single recognized board.

\* In case a candidate has passed subjects/s from more than one board, s/he can appear for CUET 2022 in the subjects in which she/he has passed Class XII; however, for the purpose of ascertaining the Minimum Eligibility, the marksheets/ degree of only one board will be considered (For example, If a candidate has appeared in CBSE Board Examination with five subjects except for Mathematics and later appears and passes Mathematics from another board such as the National Institute of Open Schooling (NIOS), the minimum eligibility shall be ascertained from his/her mark sheet issued by CBSE only).

The marks obtained by the candidate in CUET 2022 will be considered for computing the total marks according to the Program- Specific combinations of subjects for deciding merit and granting admissions in the undergraduate programs. Merit will be based only on the combination of subjects

in which a candidate has appeared in CUET 2022 as mentioned in the respective Program-Specific Eligibility.

## **2.9 Reservations and Relaxations**

### **2.9.1 Reservation of Seats for Scheduled Caste (SC)/Tribe (ST) applicants**

22.5% of the total numbers of seats is reserved for Candidates belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7.5% for Scheduled Tribes, interchangeable if necessary).

The Candidate must be in possession of the Caste/Tribe certificate in his/her own name at the time of Registration and Admission. The Caste certificate should clearly state:

- (a) Name of his/her caste/tribe
- (b) Whether candidate belongs to SC or ST
- (c) District and the State or Union Territory of Candidate's usual place of residence, and
- (d) the appropriate Govt. of India Schedule under which his / her caste / tribe is approved as SC or ST.

**Candidate will have to produce the valid original SC or ST caste/tribe certificate** at the time of admission. The following are empowered to issue the requisite SC / ST certificate:

- a. District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Addl. Deputy Commissioner / Deputy Collector / 1st class Stipendiary Magistrate / City Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
- b. Chief Presidency Magistrate / Addl. Chief Presidency Magistrate / Presidency Magistrate.
- c. Revenue Officer not below the rank of Tehsildar.
- d. Sub- Divisional Officer of the area where the Candidate and/ or his family normally resides.
- e. Administrator / Secretary to the Administrator/ Development Officer (Lakshadweep Islands).

Candidates to note that the SC / ST Certificate **from any other person / authority shall not be accepted in any case. If the Candidate happens to belong to SC or ST, Candidate's caste / tribe must be listed in the appropriate Govt. of India Schedule.**



It is a statutory obligation on the part of Colleges to fill all seats reserved for Scheduled Caste / Scheduled Tribe Candidates.

Colleges shall not refuse admission to any SC / ST Candidate on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be addressed; for this purpose, remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.

#### **2.9.2 Reservation of Seats for Other Backward Classes (OBC, Non-Creamy Layer, Central List)**

27% seats are reserved for the Candidates belonging to Other Backward Classes (OBC - Non-Creamy Layer, Central List).

At the time of giving admission to an OBC Candidate, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes (available at the website [http://ncbc.nic.in/backward\\_classes/index.html](http://ncbc.nic.in/backward_classes/index.html).)

The certificate must mention non-creamy layer status of the Candidate (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93- Estt. (SCT) dated 15.11.1993). The OBC Candidates who belong to the 'Non-Creamy Layer' and **whose caste appears in the Central List of the OBCs only**, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the Candidates as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res- I) dated 31 March 2016). The certificate should be issued on or after 31st March, 2022.

It is a statutory obligation on the part of Colleges to fill all the seats reserved for OBC Candidates.

#### **2.9.3 Reservation policy for Economically Weaker Sections (EWS)**

As per the University of Delhi notifications (Reference No. Aca. I / Reservation of EWSs / 2019/ 63 Dated 28th March 2019 and Reference No. Aca. I / Reservation of EWSs / 2019 / 101 Dated 15th May 2019), for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission of candidates belonging to EWS category .

#### **2.9.4 Admission to Supernumerary Seats**

**Admission to all supernumerary seats will be through CUET 2022. Candidates desirous of taking admission on Supernumerary seats must appear in CUET 2022.**

### A. Locomotor Disability

Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including—

1. **"leprosy cured person"** means a person who has been cured of leprosy but is suffering from—
  - i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifestation of deformity;
  - ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
  - iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
2. **cerebral palsy** means a Group of non- progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth.
3. **"dwarfism"** means a medical or genetic condition resulting in an adult height of 4feet 10 inches (147 centimeters) or less;

4. "**muscular dystrophy**" means a group of hereditary genetic muscle disease that **weakens** the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;
5. "**acid attack victims**" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

## **B. Visual impairment**

1. "**blindness**" means a condition where a person has any of the following conditions, after best correction
  - i) total absence of sight; or
  - ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
  - iii) limitation of the field of vision subtending an angle of less than 10 degree.
2. "**low-vision**" means a condition where a person has any of the following conditions, namely:
  - i) visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
  - ii) limitation of the field of vision subtending an angle of less than 40 degree upto 10 degree.

## **C. Hearing Impairment**

3. "**deaf**" means persons having 70 DB hearing loss in speech frequencies in both ears;
4. "**hard of hearing**" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
5. "**speech and language disability**" means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.

## D. Intellectual Disability

A condition characterised by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including—

1. "**specific learning disabilities**" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;
2. "**autism spectrum disorder**" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

## E. Mental Behaviour

"**Mental illness**" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognise reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterised by subnormality of intelligence.

## F. Disability caused due to Chronic neurological conditions, *such as*—

1. "**multiple sclerosis**" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
2. "**Parkinson's disease**" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.

## G. Blood Disorder

1. "**haemophilia**" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterised by loss or impairment of the normal clotting ability of blood so that a minor wound may result in fatal bleeding;
2. "**Thalassemia**" means a group of inherited disorders characterised by reduced or absent amounts of haemoglobin
3. destruction of the cell membrane of red blood cells resulting in the release of haemoglobin.

4. "**Sickle cell disease**" means a haemolytic disorder characterised by chronic anaemia, painful events, and various complications due to associated tissue and organ damage; "haemolytic" refers to the

## **H. Multiple Disabilities (more than one of the above specified disabilities)**

Multiple disabilities including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.

**Any other category as may be notified** by the Central Government.

## **Concessional/Waiver of fees in respect of Persons with Benchmark Disabilities (PwBD)**

- a. Candidates with physical disabilities pursuing various programs of study in the Faculties, Departments, Centres, and Institutions / Colleges of the University shall be **exempted from payment of fees, including examination fee and other University fees**, except Admission fee, subscription towards Delhi University students' Union and Identity Card fee(As per amendment to Ordinance X(4) of the University).
- b. PwBD Candidates who meet the merit for the unreserved category and will take admission in the unreserved category (UR) will pay the fee relevant for PwBD Candidate.
- c. As per the Executive Council Resolution No. 50 dated 03.11.2012, students with physical disabilities residing in different Hostels / Halls of the University are **exempted from payment of all hostel fees and charges** except refundable caution fee and the mess fees. Persons with Physical Disabilities who are students shall pay 50% of the Mess fee and the remaining **50% of their Mess Fee** will be met by the University of Delhi. **Similar norms are to be adopted by the Colleges in respect of PwBD Students residing in various hostels of the Colleges.**
- d. PwBD students who are getting fellowships / financial assistance shall be exempted from payment of fees / charges / mess fees subject to the following conditions

## 2.9.6 Reservation for Children/Widows of Personnel of the Armed Forces (CW)



Five percent (5%) of seats are reserved for Candidates under this category, program-wise in all colleges.

**Candidates desirous of taking admission under the CW quota of the University must appear in CUET 2022.**

All such Candidates have to upload the Educational Concession certificate issued by **any of the following authorities** on the proper letterhead:

- i. Secretary, Kendriya Sainik Board, Delhi.
- ii. Secretary, Rajya Zila Sainik Board.
- iii. Officer-in-Charge, Record Office.
- iv. 1st Class Stipendiary Magistrate.
- v. Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

No other format shall be permissible. Proofs of the CW category in the form of ID card of parent or dependent, Medical card, Ration card, CSD card, etc. are not admissible in lieu of certificate in correct format. The priority must be clearly mentioned in the certificate. Certificates that do not mention the relevant priority will not be considered.

Admission may be offered to the Children/Widows of Personnel of the Armed Forces (**Priority to IX**) including Para- Military Personnel (**only Priority I to V**), in the following order of preference:

<b>Priority I</b>	Widows/Wards of Defence personnel killed in action;
<b>Priority II</b>	Wards of Defence Personnel disabled in action and boarded out from service with disability attributable to military service;
<b>Priority III</b>	Widows/Wards of Defence Personnel who died while in service with death attributable to military service;
<b>Priority IV</b>	Wards of Defence Personnel disabled in service and boarded out with disability attributable to military service;
<b>Priority V</b>	Wards of Ex-servicemen and Serving personnel, including personnel of police forces who are in receipt of Gallantry Awards;

**Candidates desirous of taking admission under the Kashmiri Migrants quota must appear in CUET 2022.**

#### **2.9.8 Prime Minister's Special Scholarship Scheme for J&K students**

**Candidates desirous of taking admission under the Prime Minister's Special Scholarship Scheme for J&K students must appear in CUET 2022.**

#### **2.9.9 Nomination of Seats for Sikkimese Students**

**Candidates desirous of taking admission under the Sikkim nomination scheme must appear in CUET 2022.**

Sikkimese students nominated by the Govt. of Sikkim shall be considered for admission by the University in Colleges where hostel facilities are available (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges be made by the Vice-Chancellor at his discretion.

**For admissions to ECA and Sports supernumerary seats a weightage of 25% will be given to CUET score and 75% to certificates/trials/performances.**



- Re-admission of the defaulters will be at the discretion of the Principal and such students will have to pay readmission fee of Rs.5/- besides other dues. Re-admission will be granted only once a year'

## 2.16 REFUND POLICY

## 3 COLLEGE

### 3.1 ABOUT US

SPM College is a well-known women's college of the University of Delhi. It was established in 1969 in memory of Dr. Shyama Prasad Mukherji.

The college has a highly accomplished faculty and excellent infrastructure that caters to the needs of over 3000 students. The infrastructure and amenities include a spacious building, gardens, sprawling lawns and playgrounds, a state-of-the art fully air-conditioned auditorium, a fully computerized library, a well-equipped gym, ICT-enabled classrooms, Computer labs, Psychology lab, Food & Technology lab, seminar hall, Audio-Visual room, a web access centre and various other facilities.

The college offers various undergraduate and post-graduate courses in Humanities and Commerce streams. The College also offers Teacher's Training Programmes – B.Ed & B.El.Ed. We are proud to say that SPM is among the few colleges of the University of Delhi to have a B.Ed. course. Besides offering full-time courses, the college also runs centres for the Non-Collegiate Women's Education Board and the School of Open Learning over the weekend. The college has a Family Counselling Centre for students established by the Social Welfare Board, Delhi.

The student demography of the College is heterogeneous. Government norms for the reserved categories are duly followed in the admission process. North-Eastern states are well represented in the student body. Students from Tibet are also enrolled in the institution. Special provisions are in place for differently-abled students and staff members. Adequate infrastructural support is provided (such as ramp, wheel chairs, washrooms, and special pavements) to smoothen their movement within the college premises. Keeping in mind the requirements of our outstation students, the foundation stone for the college hostel was laid in August 2021. The construction for the same is underway.

SPM College is located in Punjabi Bagh (West), New Delhi. It is well connected by the Shivaji Park Metro Station.

### 3.2 DEPARTMENT PROFILES

#### **Department of Applied Psychology**

The Department of Applied Psychology was established in the year 2006 in the college. Being one of the youngest departments of the college, it has been nurtured and groomed like a sapling which is now thriving along with other courses offered by the college. Psychology as a subject is the scientific study of human behaviour, and applied psychology uses approaches and findings of psychology to resolve practical difficulties of human behaviour and experience. The department offers the students opportunities to probe



into human phenomenon, and sensitize them towards the happenings of society, and help them not only in becoming professional psychologists but responsible and sensitive individuals who respect & nurture human diversity.

The courses offered by the Department include B.A. Honours and Generic Elective. The undergraduate program of Applied Psychology has been designed in such a way that it provides both theoretical as well as practical knowledge in various sub-domains of psychology such as Applied Social Psychology, Clinical Psychology, Organizational Behavior, Research Methodology and Developmental Psychology etc. All these papers are supplemented with practicum papers for training students in different forms of assessment and research. To enhance teaching and learning process, various pedagogical tools are used such as case studies, lectures, audio-visual aids, role-plays, projects, in-house paper presentations, seminars, talks by eminent speakers, movie screenings, and workshops.

Mental Health Day has been organized in the college by the department every year since 2007 where assessment of college students is carried out in various aspects like personality, aptitude, intelligence, self-esteem etc. and feedback and interventions are provided to those who require these and are interested. ## Department of Computer Science

The Department of Computer Science at SPM College was established in the year 1999. ### **Department of Economics**

The Department of Economics is one of the oldest departments of the college and was established in 1969. At present the department offers the following courses: B.A. Honours, Economics in B.A. Programme, and Generic Elective courses for B.A. Honours in subjects other than Economics. The core papers in all these courses cover topics in Microeconomics and Macroeconomics, with focus on understanding consumer behavior, producer behavior, money creation, determination of prices, rate of interest etc. In addition, these courses also expose students to Indian economic experience in the areas of growth, employment, external sector balance, government taxation and expenditure policy.

The Honors course requires a good deal of mathematical aptitude and includes papers on Mathematical Economics, Statistics and Econometrics. The analytical tools the students learn in the Honors courses enable them to analyze issues in Environmental Economics, Health Economics and International Trade.

The medium of instruction is English for Honors courses, though bilingual teaching is often practiced for a better understanding of the subject.



The Economics Association of the department offers a platform to the students, under the guidance of a faculty member, to organize co-curricular activities like debates, quizzes, discussions etc.

The skills acquired in the courses we offer are highly valued in the job market and many of our students have successfully built their careers in banking, software companies, NGOs and teaching in schools and colleges. ### **Department of Education**

The Department of Education offers two professional programmes in Education: Bachelor of Elementary Education (B.El.Ed) and Bachelor of Education (B.Ed). B.El.Ed is a four-year teacher preparation programme that can be undertaken by students who have completed +2 level of education. It prepares teachers who are eligible to teach up to the elementary level. B.Ed is a two-year teacher preparation programme that can be undertaken by students after graduation or post-graduation. It prepares teachers up to the senior secondary level.

## Department of Philosophy

### **Department of Sanskrit**

The Department of Sanskrit in our college came into being in the year 1969, with the establishment of the college in the same year. The Department offers the following courses: Honours in Sanskrit, Sanskrit in B.A. Programme, and M.A. in Sanskrit. The discipline of Sanskrit is highly diversified. The focus of the curriculum is mainly on: Literature (classical and modern), Paninian Grammer, Indian Philosophy, Indian Scientific Heritage, Indian Logic and Science of Debate, Sanskrit Linguistics, Vedic Literature, Aesthetics, Theatre and Poetics, Ancient Mathematics and Astronomy, Dharmashastra, Epigraphy and Paleography, Ancient Indian Polity, Computational Sanskrit, Personality Development and script writing. We attempt to enable students to appreciate different forms and genres of literature and to become aware of the rich intellectual traditions of India.

For the students of other departments, we offer Generic Elective courses which are of interdisciplinary nature and aim to enrich students in an additional field of study. They include, Indian Culture and Social Issues; Individual, Family and Community in Indian Social Thought; Fundamentals of Indian Philosophy; and Aesthetics. We also offer Sanskrit as MIL for all undergraduate students. The medium of instruction is Hindi, Sanskrit or English, as per the requirements of the students. Mode of examination can be Hindi, English & Sanskrit. The students who have not studied Sanskrit in the 10+2 level are also eligible for admission in Sanskrit (Honors) as well as Sanskrit (Programme) courses. Those girls who will take admission in B.A. Programme in Sanskrit can get 5%-10% relaxation in Marks.

Our Departmental Association conducts many co-curricular activities at inter-college and intra-college levels for students to hone their skills in areas such as shloka recitation, quiz, speech, debate, acting, kaavyaali and essay writing. Occasionally we take our students for academic excursions also. Brilliant students will get scholarship also. Every year students along with teachers are given an opportunity to edit the Sanskrit Section of the College magazine 'Shyama'.

### **Department of Sociology**

The Department of Sociology was established in 1990 with the B.A. Programme course. The focus of the course is two-fold: to introduce main sociological concepts and theories to the students, and to relate and link the theoretical understanding to the actual experiences of life. We rely heavily upon the use of movies, newspapers, posters etc. Evaluation is a continuous process that takes place through assignments, presentations, projects, tests and examination. ### **SAMBAL – Financial Assistance Program**

1. Partial or full fee concession may be granted to the economically weak students. Applications for fee concession must be submitted on the prescribed form obtainable from the Accounts Section, duly supported by an income certificate attested by the Magistrate/Civil Officer/Employer. The application, complete in all respects, must be submitted to the accounts section before the last date.
2. Fee concessions granted are subject to good conduct, regular attendance, and satisfactory progress in studies, and may be withdrawn anytime if a student is found neglecting any of these.
3. Students belonging to Scheduled Caste/Scheduled Tribes are awarded Post-Matric Scholarships by the Directorate of Education, Delhi Administration. Forms will be available in the College Office. These should be filled in neatly, accompanied by necessary certificates/documents before submission in the office.
4. All forms will be available in the college office free of charge. In addition to the above concessions, ad-hoc grants may be given from "Student Aid Fund". Students desiring to avail this aid must contact the Convener of Students Aid Committee.
5. Notices of scholarships granted by Delhi Administration, University of Delhi or other agencies are displayed on the College Notice Board and college website from time to time as and when they are received.
6. Shri Vijay Chandola Memorial Fund is given to the needy students of the college.

### **3.8 Library Committee**

The library plays a significant role as a learning resource centre for the faculty and students. Our library is fully computerized with the Online Public Access Catalogue (OPAC) form for easy and quick access to all



resources. Students and teachers can check the availability of books and journals in the library from various terminals and get them for issue, reference or photocopy. The library has a rich collection of text books and reference books, which includes encyclopaedias, yearbooks, dictionaries, atlases, general knowledge books, general reading books, biographies, autobiographies and latest fiction in English and Hindi languages. Our collections include nearly 81,200 books, 81 periodicals (36 journals and 45 magazines), 10 daily newspapers in English and Hindi, and electronic resources including online databases accessible through UGC INFONET, CDs, DVDs, e-journals, and e-books. The library has subscribed to N-LIST “National Library and Information Services Infrastructure for scholarly content”, which is jointly executed by the e-Shodh Sindhu consortium, INFLIBNET Centre and INDEST –AICTE consortium, IIT Delhi. The N-LIST database is specially meant for college libraries; this provides access to e-resources to faculty, researchers and students. Users can download articles required by them directly from the publisher’s website once they are duly authenticated. Passwords are provided to library members for remote access to N-LIST and DULS e-resources. A book bank that runs with the help of grants from International Punjabi Society helps the students from economically weaker sections. A Braille book collection and 1066 audio books collection is also available in the library. The information Centre in the library has 25 computers with internet facility for the students to do their assignments and research work. Free access to more than 6000 journals with full text information, e-resources, e-books, e-databases are available through UGC INFONET. The information Centre has Wi-Fi connectivity. Library premises are a Wi-Fi enabled zone for all users. Recorders and laptops with special software are available for the differently-abled students. Every year a Book Exhibition is organized in the college premises by the library for faculty and students.

2. The library has a seating capacity of 150 students and also has reading room facility.
3. The library has a lift facility for the differently abled.

Annual theatre workshops – in online and offline mode – were conducted leading to successful production of the play ‘Amrita’ which was streamed on YouTube. #### **Dance Society ‘Thirkan’**

### **3.13 Eco Club: Durva**

Eco club is a dynamic and active club of the college. It is funded by the Department of Environment, Govt. of NCT, Delhi. The Eco Club aims to create awareness about environmental issues, and encourages students to adopt the principles of 3R's – Recycle, Reuse and Reduce. The Eco Club organizes a wide range of activities such as lectures, workshops, plantation drives, street plays, inter college competitions, poster making competitions, debates, paper presentations, and visits to biodiversity parks. The college is equipped with paper recycling machine that is used to recycle waste paper for making folders, envelopes, and invitation cards for college functions. The Eco club also works towards conservation of environment by adopting eco-friendly and energy saving measures such as installation of solar street light in the college campus. The Eco-club organizes Hariyali Divas with plantation drive every year in order to mark the onset of monsoon. On the occasion of Annual Sports Day, a march past is performed by the students of the college with the theme of environmental conservation. This year the focus will be on organizing workshops for the students and giving them a platform to interact with experts from various fields of environment. More than 450 students have registered for membership of the club.

### **3.14 Sports, NCC, NSS**

#### **Sports**

Our college has a very active sports department. Our students bring accolades and distinctions in various university competitions, and also in competitive events held at the state, national, and international levels. To ensure mental fitness along with physical strength, the department organizes Yoga and Aerobic classes twice a week for the whole year.

#### **NCC**

Constant efforts are made to introduce new aids in the college so as to serve the interests of the differently abled better. Cultural events like 'Kavi Sammelan' are held to give our students a platform to showcase their talents.

## **Chetna**

The Enabling Unit of the college, Chetna, works consistently for inclusion of students with disability. It conducts a variety of activities that aim to sensitize the general student body about the challenges that its members face. The college provides infrastructural facilities like ramps, tactile paths, lifts and washrooms for the differently abled. Hundred percent fee waivers are also given to the differently abled by the college. Special counselling is done during the admissions to facilitate their admission into the college. Under the aegis of the college, Chetna provides sophisticated aids and equipment like DAISY recorders, laptops with NVDIA software providing translations in all Indian languages and LEX screening machine that enables the differently abled to study with greater ease. QR Code enabled signage(s) have been installed in the entire college for students with visual challenges. This is the first of its kind initiative by a Delhi University college to create a unique inclusive space. Cultural events like 'Kavi Sammelan', fun events like 'Treasure Hunt' are held which bring to light the multifaceted abilities of the differently abled. 'Read for Me' program has been initiated by Chetna, whereby student volunteers are encouraged to record syllabus related content for the visually impaired students. The audio material is being catalogued in a hard drive with an objective to build an archive so that more students could avail benefit.



### **3.16 Prayas & Samavesh Cell**

The College has started new committees for furthering good causes like, ‘Sab Padhe, Sab Badhe’ to provide financial aid to those students facing financial crisis and full fee concession for economically weak students and SC, ST students, and to take learning initiatives for visually challenged students, in order to promote inclusivity in the college. These committees are:-

1. Prayas
2. Samavesh

### **3.17 North-East Cell**

SPMC has a North-East Cell. The cell gives necessary counselling to students from Northeast India. Interactions and internal discussions are held periodically. It also creates awareness about the diverse history, ethos, and culture of Northeast India in a way that sensitizes people from other parts of India. It works to build bridges of understanding between students from North-East and other parts of the country.

### **3.18 Placement Cell**

The Placement Cell of SPMC is emerging as a new strength for the college. The placement cell provides career guidance about avenues open after graduation i.e., higher education, placements or entrepreneurship. It connects students with potential employers for both internship and job opportunities. It also provides a platform to get students placed in reputed multinationals, government Organisations, NGOs, and the private sector. In coordination with the Central Placement Cell (CPC) of University of Delhi, it tries to provide students with suitable internship and job opportunities. The CPC also conducts seminars and workshops to enable the students to become successful professionals. The placement cell of the college includes teacher and student coordinators who work diligently to help students identify their potential and map it with the available opportunities. Our vision is not only to let them get jobs but also to inculcate values of working for society. In the past few years, the college had successful campus placements with many students getting recruited in well-known companies like Genpact, DICCI SME Portal, Jet Airways, Tata Power, KVC Consultancy etc.

### **3.19 Mentorship Programme**

The Mentorship Programme was started in the year 2016-2017. Each student is allocated a teacher as Mentor. Regular meetings are held to provide students a platform where they can discuss their problems and concerns. Teachers act as facilitators to help students resolve their issues.

### **3.20 Medical Committee and Family Counselling Centre (FCC)**

The college has an active Medical Committee with a full-time trained nurse. FIRST AID FACILITY is also available for students and staff members. Apart from these basic amenities, several talk sessions are organized time and again, wherein doctors and experts give their insights into certain health related issues and general wellbeing.

The Family Counselling Centre provides counselling, referral and rehabilitative services to those who are facing problems like family maladjustment, atrocities or social ostracism. The FCC also has a library with books and CDs that students can use. Each student of the college is an important member of the centre and may feel free to seek assistance from the centre to solve personal, social or educational problems. The FCC is also taking new initiatives for reaching out to the local community.

### **3.21 COLLEGE MAGAZINE (SHYAMA)**

The college magazine SHYAMA is published every year. Students are encouraged to contribute to its three sections - Hindi, English and Sanskrit. Student editors under the guidance of the teacher advisors manage the magazine.

### **3.22 Alumni**

Alumni Committee plays a vital role in ensuring a link between generations of students who have passed out to the ones who are currently enrolled. An Alumni Meet is held every year to honor the alumna of the college and felicitate them for their outstanding achievements. The tradition of inviting the students back to their alma mater, helps build a strong relationship with the institution, resulting in a harmonious exchange of information and sharing of experiences.

### **3.23 Vocational and Talent Development Centre: Ruchika**

The centre runs a few short-term vocational courses throughout the year. These self-financing courses enable students to acquire sought after skills during their free periods or leisure hours. The diploma and certificate courses offered are:

1. Cutting and Tailoring; 2. Embroidery; 3. Dress Designing & Drafting; 4. Secretarial Practice Course with Computers (Stenography English); 5. Advanced Course in Stenography

## **4 ORDINANCES AND OTHER**

### **RULES 4.1 ORDINANCES**

#### **4.1.1 ORDINANCE XV-B**

##### **Maintenance of discipline among Students of the University**

1. All powers relating to discipline and disciplinary action are vested in the Vice - Chancellor.
2. The Vice-Chancellor may delegate all or such powers as he / she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:
  - a. Physical assault, or threat to use physical force, against any member of the teaching and nonteaching staff of any Institution / Department and against any student within the University of Delhi
  - b. Carrying of, use of or threat to use of any weapons
  - c. Any violation of the provisions of the Civil Rights Protection Act, 1976
  - d. Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes
  - e. Any practice-whether verbal or otherwise-derogatory of women
  - f. Any attempt at bribing or corruption in any manner
  - g. Willful destruction of institutional property
  - h. Creating ill-will or intolerance on religious or communal grounds
- i. Causing disruption in any manner of the academic functioning of the University system;
- j. Prohibition of Ragging as per Ordinance XV-C.
4. Without prejudice to the generality of his / her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor, may in the exercise of his / her powers aforesaid order or direct that any student or students -
  - a. be expelled; or
  - b. be, for a stated period rusticated; or
  - c. be not for a stated period, admitted to a course or courses of study in a College, Department or Institution of the University; or
  - d. be fined with a sum of rupees that may be specified; or
  - e. be debarred from taking a University or College or Departmental Examination or Examinations for one or more years; or that the result of the student or students concerned in the Examination or Examinations in which he /she or they have appeared be cancelled.
5. Institutions, Halls and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.

6. Without prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules. At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Vice-Chancellor and several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the rules that have been framed therein by the University.

#### **4.1.2 Ordinance XV-C**

##### **Prohibition and Punishment for Ragging**

1. Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of Delhi University system as well as on public transport.
2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students; and includes individual or collective acts or practices which
  - a. involve physical assault or threat to use of physical force.
  - b. violate the status, dignity and honour of women students.
  - c. violate the status, dignity and honour of students belonging to the scheduled caste and tribe.
  - d. expose students to ridicule and contempt and affect their self-esteem.
  - e. entail verbal abuse and aggression, indecent gestures and obscene behavior.
4. The Principal of a College, the Head of the Department or an Institution, the authorities of College, or University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging.
5. Notwithstanding anything in Clause (4) above, the Proctor may also suomoto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advise the Vice-Chancellor accordingly.
8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.

9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under clause (7) disclosing the occurrence of ragging incidents described in Clause 3(a), (b) and (C), the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.

10. The Vice-chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.

11. In case any students who have obtained degrees or diplomas of Delhi University are found guilty; under this Ordinance, appropriate action will be taken under Statute 15 for withdrawal of degrees or diploma conferred by the University.

12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice or incitement of ragging will also amount to ragging.

13. All Institutions within the Delhi University system shall be obligated to carry out instructions/directions issued under this Ordinance, and to give aid assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

**Note: Order of the Vice-Chancellor in pursuance of Ordinance XV-C:**

Where incident(s) of ragging are reported to the Vice-Chancellor by any authority under this Ordinance, the students(s) involved in ragging, shall be expelled for a specified term, designated in the order. Non students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi. Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice.

#### **4.1.3 Ordinance XV-D**

#### **The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (MINISTRY OF LAW AND JUSTICE)**

An Act to provide protection against sexual harassment of women at work place and for the prevention and redressal of complaints of sexual harassment and for matters connected there with incidental thereto.

WHEREAS sexual harassment results in violation of the fundamental rights of a woman to equality under articles 14 and 15 of the Constitution of India and her right to life and to live with dignity under article 21 of the Constitution and right to practice any profession or to carry on any occupation, trade or business which includes a right to a safe environment free from sexual harassment;

AND WHEREAS the protection against sexual harassment and the right to work with dignity are universally recognized human rights by international conventions and instruments such as Convention on the Elimination of all forms of discrimination against Women, which has been ratified on the 25th June, 1993 by the Government of India.



AND WHEREAS it is expedient to make provisions for giving effect to the said Convention for protection of women against sexual harassment at workplace.

## **4.2 ATTENDENCE RULES**

Ideally a student should attend all lectures, preceptorials, tutorials and practical classes held during the semester in all subjects/ papers. In case a student is unable to do so, then she must have:

· A minimum of 66.67% attendance in lectures, preceptorials, tutorials and practical classes separately (in all subjects or papers) in each semester failing this she will not be permitted to appear in university examination.

College strictly follows the ordinance laid down by the University of Delhi on attendance requirement as prerequisite for taking the semester examination. Hence admission seekers and their guardians are requested to make a note of this. Please note the following:

- **You are not allowed to join any additional course/job/ coaching during college hours.**
- **Compulsory attendance of 66.67% is required in the total for all courses in Theory/ Practical/Tutorial classes as per rules laid down by the University of Delhi. Those who fail to secure the mandatory attendance will be DETAINED in the semester examination.**
- **Attendance is uploaded on college website on monthly basis. Individual letters will not be sent.**
- **Marks will be given to those whose attendance is more than 66.67%.**
- **If any student is admitted in first year after opening of the college, her attendance will be counted from the date of admission.**

## **MEDICAL CASES**

A student may get benefit for any classes missed because of critical medical illness/ accident disabling her from attending classes.

An application along with the following supporting documents is to be submitted within 10 days of rejoining the college

- Prescription of doctor
- Medical certificate
- Hospital papers (if admitted)
- Test reports

No overwriting on the medical certificate/ other documents is allowed. Certificates must have the doctor's registration number and area of specialization for verification.

Attendance may be condoned in exceptional cases of serious illness or accident by the principal.

Submission does not mean acceptance.



The submitted applications will be checked and the list of incomplete applications will be displayed on the college notice board monthly. It is the responsibility of students to submit the required documents within the specified time period, failing which the application will be rejected.

Each case will be decided on its merit.

#### Points to remember

1. These lectures can be excluded for purpose of calculation of attendance for eligibility to appear in the exam only. In no case, they will be considered for credit towards marks for regularity.
2. The maximum benefit to be given, can be up to 1/3<sup>rd</sup> of the total number of lectures/ tutorials/ practicals held.

#### **Participation in NCC/ECA/Sports**

When a student is required to represent the college in competitive games, athletics, cultural activities, debates etc. sponsored by the college, she must take the permission from the principal so that her absence from classes is accounted for.

All the students who participate in NCC/ECA/sports will be given benefit only for the day of actual participation/ performance. After the event it is mandatory to submit the supporting documents/ proofs for participation.

No benefit will be given for practices done as they should be held after classes or in the activity period.

Actual number of lectures held during the period when the student is absent (if authorized previously by the convener of that committee and principal) can be considered as attended by the student. This benefit will be given for calculating credit towards marks to be awarded regularity in internal assessment.

Every student admitted to the college for the academic session 2020-21 shall be compulsorily required to sign an undertaking that she will fulfill the minimum attendance requirements failing which the college shall have the right to take necessary action.

Students should carefully note that attendance rules are prescribed by the University and no relaxation is possible. **THESE RULES ARE RIGIDLY AND STRICTLY ENFORCED. THE PRINCIPAL'S DECISION IN THIS REGARD SHALL BE FINAL AND BINDING.**

The principal of the college shall have power to strike off the name of a student who is grossly irregular in attendance in spite of warning or when the absence of the students is for such a long period that she cannot put in requisite percentage of attendance.

Students should regularly see the Notice Board/ website for circulars pertaining to attendance.

Attendance rules for the 3-year semester based undergraduate programmes (Ordinance 7 (2))

a) A candidate for the Semester I/III/V Examination shall not be deemed to have satisfied the required

conditions of attendance unless s/he has attended, in all the subjects taken together, not less than two-thirds of the lectures/ practical/presentations/tutorials required to be attended.

Provided that, a student of the Semester I/III/V who does not fulfil the required conditions of attendance, as above /but has attended, in all the subjects taken together, not less than 40 per cent of lectures/practical presentations during the respective semester, may at the discretion of the Principal of the College concerned, appear for the ensuing semester examination; but such a candidate shall be required to make up the deficiency at lectures and practical's, in the next semester of the same academic year.

Provided that a student of the II/IV/VI semester who does not fulfil the required conditions of attendance as above, but has attended in all the subjects taken together, not less than 40 per cent of the lectures/ practical/ presentation/tutorials, held during the respective semester, may at the discretion of the Principal of the College concerned, be allowed to appear at the ensuing examination provided that she/he makes up the deficiency of the said attendance by combining the attendance of the previous semester in the ensuing semester.

Provided further that the Principal of the College concerned may permit a student to appear in an examination notwithstanding that the student has not fulfilled the attendance requirement, if in the opinion of the Principal, such student shall make up the deficiency in the succeeding academic year.

Provided further that a student of the VI semester shall be allowed to appear at the VI Semester Examination, if by combining the attendance of the three academic years, the candidate has put in two-thirds of attendance, in all the subjects taken together, held during the respective years.

b) In the case of a student who:

- i) is selected as a member of the N.C.C. to participate in the annual N.C.C. Camps or is deputed to undertake Civil Defense work and allied duties; or
- ii) is enrolled in the National Service Scheme and is deputed to various public assignments by or with the approval of the Principal/ Head of the institution concerned; or
- iii) is selected to participate in sports or other curricular activities; or
- iv) represents the college in inter-college tournaments organized by the Delhi University Sports Council (DUSC); or a student who represents Delhi State in National Tournaments organized by (Nation) Sports Federation; or a student who represents the University in Tournaments organized by Association of Indian Universities; or a student who represents India in International Tournaments organized by International Federation/ Associations and FISU, (selection through AIU); or a student who represents India in Olympics/Common Wealth Games/Youth Games/World Championship organized by International Olympic Committee; or in national or international fixtures in games and sports approved by the Competent Authority; or
- v) is required to represent the University at the Inter- University Youth Festival; or
- vi) is required to participate in periodical training in the Territorial Army or a student who is deputed by the College to take part in Inter-College sports or fixtures, debates, seminars, symposia or social work projects or a

student who is required curricular activities held in other Universities or such other activities approved by the Vice-Chancellor for this purpose In calculating the total number of lectures etc. delivered in the College, or in the University, as the case may be, for his/her course of study in each academic year, the number of lectures etc., in each subject delivered, during the period of absence, and as recommended/forwarded by the concerned teacher/DPE and approved by the Principal/Head for the above purposes shall be deemed to have been attended by the student.

- c) The Principal of a College may consider, on the basis of the Medical Certificates produced exceptionally hard cases of students who had fallen seriously ill or had met with an accident during the year disabling them from attending classes for a certain period, with a view to determining whether the lectures etc. delivered during the said period, or a part thereof, could be excluded for purposes of calculation of attendance of the year and decide each case on its own merits.
- d) Colleges shall be required to notify the attendance position of each of its students for each month on the notice board of the College, and clearly indicate the lectures/practical held subject wise and the numbers attended by each student.
- e) A College shall notify on the notice board the final attendance position of each of its students within five days of the dispersal of the classes in the last session of the academic year. Not later than five days, thereafter, a student may, by an application to the Principal of the college, claim benefit of exclusion of lectures under sub-clause (a) above on grounds to be specified and accompanied by the relevant documents. All such applications submitted within time shall be considered and disposed of by the Principal of the College at least 3 days prior to the commencement of the examination, in which the student is intending to appear.
- f) The benefit of exclusion of lectures contemplated in category (c) above shall in no case exceed 1/3 of the total number of lectures / practical's / presentations / tutorials.
- g) In the case of a married woman student who is granted maternity leave, in calculating the total number of lectures delivered in the College or in the University, as the case may be, for her course of study in each semester, the number of lectures in each subject delivered during the period of her maternity leave shall not be taken into account.
- h) No person shall be deemed to have satisfied the required conditions in respect of his instructions unless in addition to the requirements regarding attendance and other conditions, he has appeared and satisfied by his performance the Principal of his college in such tests, written and/or oral, as may be held by him in his discretion. The Principal of the College shall have, and shall be deemed always to have had, the power to detain a student in the same class in which he has been studying, or not to send him up for the University Examination, in case he did not appear at the tests aforesaid or his performance was not satisfactory. The Principal of a College/Head of the Institution shall have power to strike off the name of a student who is grossly irregular in attendance in spite of warning or when the absence of the student is for such a long period that he cannot put in requisite percentage of attendance.

## 4.3 Other Requirements

### 4.3.1 सूचना—पट्ट

यह प्रत्येक छात्रा का उत्तरदायित्व है कि वह प्रतिदिन सूचना—पट्ट देखें। किसी भी आदेश की अवहेलना के लिए यह तर्क स्वीकार नहीं किया जाएगा कि सूचना पढ़ी नहीं थी। यही बात विश्वविद्यालय की परीक्षाओं, परिणाम, नामांकन, छात्रवृत्तियाँ, वजीफों व अन्य प्रपत्रों पर भी लागू होगी जिन्हें महाविद्यालय के कार्यालय द्वारा घोषित अनुसूचित तारीखों पर जमा कराना होता है। यह छात्राओं का कर्तव्य है कि वे सूचना—पट्ट को विभिन्न तारीखों की जानकारी के लिए देखें तथा उन्हें बताई गई अंतिम तिथि तक अपने विकल्प जमा कराएँ। अंतिम तिथि के बाद किसी अनुरोध पर विचार नहीं किया जाएगा।

#### 4.3.1 Notice - Board

It is the responsibility of each student to check the Notice Board daily. No excuse for noncompliance with any order, based on the plea that the Notice was not read shall be accepted. The same applies to notifications issued by the University with regards to Examinations, Results, Enrolment, Scholarships, Stipends and other forms, which should be submitted as per scheduled dates announced by the College Office. It is the duty of the students to check the notice board for the dates and also submit their options by the last date intimated to them. No request will be entertained after the last date.

### 4.3.2 पहचान—पत्र

पहचान पत्र सभी छात्राओं को प्रदान किए जाते हैं। नई छात्राओं को प्रवेश के तुरंत बाद पहचान पत्र प्राप्त कर लेना चाहिए। अन्य छात्राओं को महाविद्यालय के कार्यालय से प्रत्येक वर्ष अपने पहचान पत्र को नवीकृत कराना चाहिए। महाविद्यालय परिसर में एवं उसके बाहर प्रत्येक छात्रा के लिए पहचान पत्र साथ रखना अनिवार्य है। महाविद्यालय के अधिकारियों द्वारा मांगे जाने पर छात्रा को अपना पहचान पत्र प्रस्तुत करना चाहिए अन्यथा हो सकता है कि उसे महाविद्यालय परिसर में रहने की अनुमति न मिले।

### 4.3.2 Identity-Card

Identity Cards are issued to all the students. Newly admitted students must obtain their Identity Cards immediately after their admission. Other students should get their Identity Cards renewed from the College office every year. It is essential for every student to carry her Identity card in the College as well as outside.



