This MEMORANDUM OF UNDERSTANDING (MoU) is executed on 22<sup>nd</sup> day of March 2022

BETWEEN

Centre for Social Development (Hereinafter called as CSD) a not for profit organization led by group of intellectuals and academicians to work on the social development of a deprived sections of society, having its head office at WZ-2170, Rani Bagh, New Delhi.

AND

Shyama Prasad Mukherjee College (For Women) (hereinafter called as SPM College), a college of University of Delhi with head office at Road No 57, Punjabi Bagh (West), New Delhi - 110026.

(Hereinafter individually called as the PARTY and collectively called as PARTIES)

## Objective of MoU:

Whereas the main objective of this MOU is to express the willingness of both parties to engage in the implementation of CSD new initiative and organizing various academic programs with or at SPM College.

Whereas specific activities under this MOU will be identified through consultation between the two parties.

Whereas CSD agrees to provide technical and team assistance to assist SPM College to carry out activities that will enable the students to regulate themselves and support academicians to work on various social development policies and programs.

Whereas as a preliminary activity, CSD will conduct a program training with SPM College to implement our new initiative. The results of this exercise will enable the students of Age group 18-25 (college students) to develop a healthier, more cohesive and leadership ecosystem at college for self and others. Further this will help academicians to work on social issues. These agreements will be detailed in subsequent Addendums to this MOU.

Whereas SPM College agrees to work with and coordinate with CSD in the development of their initiatives to improve and expand support to the students and professors for the programs. They also agree to allow CSD to carry out monitoring and evaluation activities to assess the impact of these activities conducted with the students or professors.

This Memorandum Of Understanding as witnessed has the following terms:

### 1. General Terms of MOU

#### A. Duration of MOU:

This MOU shall be operational upon signing and will have an initial duration of 2 years, initially, which can be extended by mutual consent. All activities conducted before this date within the vision of the joint collaboration will be deemed to fall under this MOU.

#### B. Coordination:

In order to carry out and fulfill the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities. Centre for Social Development and SPM College staff will e-meet regularly (preferably with two days' notice) to discuss progress, implementation and plan activities, accordingly.

#### C. Confidentiality:

- i. Each party agrees that it shall not, at any time, after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of business or method of carrying on the business of the other without consent of both parties.

- ii. These obligations and restrictions of confidentiality shall be effective during the term of the Contract, including any extension thereof, and, unless otherwise provided in the Contract, shall remain effective following any termination of the Contract.
- iii. The Recipient shall not be precluded from disclosing Information that is obtained by the Recipient from a third party without restriction, is disclosed by the Disclosure to a third party without any obligation of confidentiality, is previously known by the Recipient, or at any time is developed by the Recipient completely independently of any disclosures hereunder.

#### ***Termination of MOU:***

The partnership covered by this MOU shall terminate upon completion of the agreed upon period. The agreement may also be terminated with a written one-month notice from either side. In the event of non-compliance or breach by one of the parties of the obligations binding upon it, the other party may terminate the agreement with immediate effect.

#### **2. Proprietary rights**

All information, statistics and such other data that is collected by the SPM college in connection and during the course of this contract shall not be disclosed to any person or party whatsoever, without the written consent of the CSD during the term of this Agreement and thereafter. It shall be applicable to publish the impact report and other relevant information to related stakeholders with prior notification to CSD.

#### **3. Settlement of disputes**

Any dispute regarding the interpretation or implementation of this MoU or its any of the terms of the MoU will be resolved amicably and mutually through mediation between the parties where the place of mediation shall be New Delhi and the language to be used in the mediation shall be English.

If, and to the extent that, any such dispute, controversy or claim has not been settled pursuant to the mediation within 90 days of the commencement of the mediation then it shall, upon the filing of a Request for Arbitration by either party, be referred to and finally determined by arbitration in accordance with The Arbitration and Conciliation Act 1996.

Alternatively, if, before the expiration of the said period of 90 days, either party fails to participate or to continue to participate in the mediation, the dispute, controversy or claim shall, upon the filing of a Request for Arbitration by the other party, be referred to and finally determined by arbitration in accordance with the Arbitration and Conciliation Act 1996. The arbitral tribunal shall consist of a sole arbitrator to be mutually appointed by both the parties after discussion. The place of arbitration shall be New Delhi. The language to be used in the arbitral proceedings shall be English. The dispute, controversy or claim referred to arbitration shall be decided in accordance with the law of Arbitration and Conciliation Act 1996.







The Eco Club was active all throughout the year with more than 15 activities conducted at college, society and community level. Some of these activities were jointly organized with EVS department and Garden Committee and some with Government organizations and NGO's. List of activities with timeline attached.

A big Environment Awareness initiative was **E Magazine** published by Eco Club and EVS Department. **Social media platforms like Facebook and Twitter** were used to spread awareness about environment issues and challenges in the covid and post covid times.

- **Enhancement of green cover (Can also add measurement of green cover area, types of plants, herbs, shrubs and other details as well)**

There are 423 fully grown trees in the college campus with two lush green lawns and a play ground. (percentage of area under tree cover is Approx.35%) The college in the past one year planted approximately 3500 plants of murraya, champa, plumeria, ficus, bougainvillea, amaltas, nerium etc. adjacent to the newly constructed 400 meters walking track in the college campus. Plant protection is done by pruning, use of organic manure and herbal spray No use of pesticides.

- **Plastic management (can include steps taken to promote reduce, reuse, and recycle)**

The college eco club in the past one year created awareness about plastic management among students (More than 4000 students are there) by conducting the following activities:

- **Public awareness drive** at various metro stations covering 6 metro lines across Delhi

The plastic waste bottles are collected and send to municipal garbage collection center on daily basis.

**Social Studies Foundation (SSF) 1196, Shivalay Apartment, Limayewadi Road, Sadashiv Peth, Pune - 411030, Maharashtra;** hereinafter referred to as the '*Second Party*'.

(Hereinafter collectively referred to as "The Parties")

**WHEREAS,** The first party is a reputed college running under the affiliation of Delhi University, which is interested to participate in conducting national seminar through its Department of Political Science.

**WHEREAS,** The second party is a well-known company engaged in education and research sector by organizing various seminars, workshops and publishing research based documents.

**AND WHEREAS,** both the parties have agreed to jointly conduct national seminar on 'Marginalization and Inclusion: Role of Marginalized Communities in India's Struggle for Freedom'.

1. SSF will finalize the concept note, theme, sub-theme and session details in consultation with Department of Political Science, SPM College.
2. The SPM College will nominate 2 resource persons/academicians who have been working on the issues related to the role of marginalized communities in India's struggle for freedom. The nominated resource persons shall be invited to participate in the seminar.
3. The organizing committee of the seminar will be constituted by SSF in consultation with Department of Political Science, SPM College. The organizing committee shall be responsible for the conduct of entire seminar starting from the preparation of call for paper, shortlisting of papers/presenters and resource persons, coordinating the journey, accommodation and hospitality of resource persons, managing stage, conduct of sessions, technical, financial and other management of the seminar for two days and submission of bill and statement of expenditures for final settlement. The organizing committee would also ensure that no charges for registration to be collected from the participants of the seminar. The paper presenters and resource persons' TA/DA allowances/reimbursement shall also be coordinated by the organizing committee.
4. The Department of Political Science of the College in consultation with SSF shall arrange the funds for the national seminar from different funding agencies. However, in the event of non receipt of funds, the SSF will be responsible for arranging / providing the funds for the seminar.
5. In the event of funds receipt from funding agencies other than SSF, the college shall reimburse the amount to SSF to the extent of funds received for the seminar.







- 6.. SPM College will not bear any expense to conduct this seminar, all the expenses will be managed by SSF and a statement of account will be submitted in the SPM College for its record.
